



Privacy Policy

User privacy is important. Outlined in this document are our Privacy Policies and Intentions.

Section One: Technical Definitions

1. For the purpose of this statement:-Indetechonline.co.nz and Indetech Hairdressing Education represents and refers to hairdressing education, salon training services and online education provided to hairdressing salons, hairdressing students, stylists and training providers.
2. Indetechonline.co.nz Web Services include services that use this website, internet social media, communication links, email, forums and online activities relating to the site.
3. Indetechonline.co.nz and Indetech Hairdressing Education and its staff and / or agencies will not ask for personal information unless we need it for the purpose of education, education resources, activities and the functionality of this site or educational training services.
4. Non-personally-identifying information includes information not directly about the user. One example may be a user's computer operating system.
5. Indirect Personally-identifying information. Information about the user that would require investigative action to identify the user. Examples could be a device I.P (Internet Protocol) address or National Student Identification Number (NSI).
6. Personally-Identifying information. Information which directly identifies a user for example, Name, address, email address or phone number.
7. Personal Information is information specifically about a users activities on the website, logs, results, grades, engagement,

Section Two: Our privacy policies

1. Indetechonline and Indetech Hairdressing education provide resources and links to relevant third party sites for the purpose of education and research therefore, DO NOT provide personal information whilst using links from this site or any of its activities unless you are sure it is legitimately for the purpose of enrolment and participation in activities at Indetechonline.co.nz or Indetech Hairdressing Education. Please contact your administrator admin@indetechonline.co.nz if you have any concerns
2. Indetechonline and Indetech Hairdressing education takes every precaution not to share personal information however does not take responsibility for information shared by the user either inadvertently or intentionally to third parties linked from this site.
3. Except to comply with the law, development of our services, or to protect our rights, Indetechonline, its staff and/or relevant agencies relating to a user's education does not share personal information with anyone.
4. Personal information is stored to enable a user to participate and use this site and the functions of this site and record details of hairdressing education.

Section Three: - Use of user information.

1. Non-personally-identifying information may be used to analyse how visitors use our web site and or our services. We may use the information to create reports, improve services and or functionality. An example may be a report on visitor logs and activities.
2. Potentially personally-identifying information such as Internet Protocol (IP) addresses for logged in users participating in the activities and resources may be visible to the administrators, site developers and technical staff of the web service. This information is never shared in any other event unless express permission in writing is provided to the system administrator OR in the event a user submits information which is considered offensive or potentially places others in danger.
3. Personally-identifying information is required for subscription to the site and to enrol for educational services, facilitation and technical training.
4. Users are automatically subscribed to relevant group mailings and forum subscriptions. Users can unsubscribe at any time.
5. We may ask users to provide personal and / financial information to process payment for subscription and or technical training or education facilitation.
6. Users can refuse to supply information. In the event a user refuses to supply information access to the services may be disabled or not permitted.
7. Except as stated in this policy Indetech will never sell or share user personal information with a 3rd party without a user's permission, unless required by law.

Section Four Who will have access to your information

1. Personally-identifying information may be shared with persons and or agencies that have a direct relationship with a user in terms of education, training and employment*. This will include, subscribed training providers, subscribed employers, site and education contractors and organisations who:
 -  Need to know that information in order to carry out facilitation of education.
 -  Require information for official education reporting and or recording of results.
 -  Are employed to carry out the maintenance and technical support of the web site
 -  Are employed to upgrade, and improve resources and functions of the site
2. Personal Information may be visible to tutors enrolled in a collaborative groups Your personal information relating to education and development, grades and engagement may be visible to tutoring and education providers for reporting, assessing effectiveness of this resource, improving the resource and assessing outcomes or progress
3. *A User can request in writing their Personal Information will not be shared with agencies or training providers however this will impede marking of assignments and some assessments and will result in all course completions and assessment results from being recorded formally for qualification purposes. Grades will be available to the user. A report will be provided directly to the user only.

Section Five; Other important information

1. The information will be stored for the duration of the subscription until three months following the termination of subscription. The exceptions will be where required by law and where information relating to course completion, achievement and educational reporting or recording purposes. These records will be maintained for five years. After that time, we will delete it from our servers and will securely dispose of any personal documentation related to users.
2. Users maintain control of their personal information and may change it at any time by contacting the system administrator admin@indetechonline.co.nz

3. Users may not share information about another user without express written permission from that user or users.
4. Users may not share images, videos or information about models posted to indetechonline except for the purpose of education within the site.
5. Users using Indetechonline (though not permitted), may intentionally or inadvertently share information or content with others publicly or privately. In this event Indetechonline and Indetech Hairdressing Education take no responsibility for what happens to user information that is shared by another user or link either intentionally or accidentally from within the site.
6. Cookies contain information that websites store on a user's device. They track web preferences and visits. We may use cookies to help us identify and update User preferences. If Users don't want cookies, set the browser to refuse cookies before using our site. Users need to know the result will be that certain features might not work.
7. In the event Indetechonline and Indetech Hairdressing education becomes bankrupt or is sold, user information would be one of the assets transferred or acquired by the parties.
8. Although most changes are likely to be minor, we may change our Privacy Policy occasionally. Except where required by law changes are at the site providers' discretion. We will communicate any significant or major changes through our website and social media.
9. Users are required to regularly check our terms and conditions and privacy statement for changes.
10. By using services provided by Indetechonline.co.nz and Indetech Hairdressing education after any change in the Privacy Policy, users are accepting those changes.
